ORDER

The President of the International Tribunal for the Law of the Sea,

Having regard to articles 24 and 27 of the Statute of the Tribunal,

Having regard to articles 45, 46, 59 and 60 of the Rules of the Tribunal,

Makes the following Order:

Whereas, by an Application submitted to the Tribunal on 24 November 2010, Saint Vincent and the Grenadines instituted proceedings against Spain in a dispute concerning the detention of the M/V “Louisa”,

Whereas Saint Vincent and the Grenadines has appointed Mr G. Grahame Bollers as Agent and Mr S. Cass Weiland and Ms Rochelle Forde as Co-Agents; and whereas Spain has appointed Ms Concepción Escobar Hernández as Agent,

Whereas telephone consultations were held by the President of the Tribunal with the representatives of the parties on 11 January 2011 to ascertain the views of the parties with regard to questions of procedure in respect of the case;

Whereas, during these consultations, the Agent of Saint Vincent and the Grenadines and the Agent of Spain agreed on the following order and time-limits for the filing of the written pleadings:
