

**INTERNSHIP PROGRAMME OF THE
INTERNATIONAL TRIBUNAL FOR THE LAW OF THE SEA**



THE KOICA GRANT

1. The Korea International Cooperation Agency Grant was endowed by means of a generous gift from the Korea International Cooperation Agency in order to assist candidates from developing countries* in covering the costs incurred in participating in the Tribunal's Internship Programme.
2. In addition to the usual criteria for participation in the programme, the following criteria are used to determine eligibility for funding for the internship:
 - (a) applicants must be nationals of a developing country included in the OECD list and should normally be resident in that country; and
 - (b) applicants should be in need of financial assistance in order to cover the travel and living costs associated with an internship in Hamburg.
3. Travel arrangements to Hamburg will be made for successful candidates using the KOICA Grant. A lump sum of up to € 750/month will also be provided at the beginning of the internship to cover the cost of accommodation and living expenses.

APPLICATION PROCEDURE

4. Persons who are interested in applying for funding for the Tribunal's internship programme should submit this form, duly completed, together with the usual application form (ITLOS/INT.2) and a covering letter of no more than one page, which should explain why an internship at the Tribunal is important to the applicant and describe how it would fit in with the academic and career goals of the applicant and what benefits the applicant expects to gain from the programme. Applications should be sent to the Tribunal no earlier than eight months and no later than three months before the start of the internship. Incomplete applications will not be considered.
5. Successful candidates will be informed at least two months before the start of the internship.

* Please note that nationals from the Republic of Korea are not eligible under the grant.
