ORDER

The International Tribunal for the Law of the Sea,

Composed as above,

After deliberation,

Having regard to article 27 of the Statute of the Tribunal,

Having regard to articles 45, 46, 59, and 60 of the Rules of the Tribunal,

Having regard to the Orders of the President of 12 January 2011 and 28 April 2011,

Makes the following Order:

Whereas, pursuant to the Order of 12 January 2011, the President fixed 11 May and 11 October 2011, respectively, as the time-limits for the submission of the Memorial of Saint Vincent and the Grenadines and the Counter-Memorial of Spain;

Whereas, pursuant to the Order of 28 April 2011, the President extended until 10 June 2011 and 10 November 2011 respectively the time-limits for the filing of the Memorial of Saint Vincent and the Grenadines and the Counter-Memorial of Spain and whereas the Memorial of Saint Vincent and the Grenadines was duly filed within the extended time-limit;

Whereas during telephone consultations held by the President of the Tribunal with the representatives of the parties on 11 January 2011, the Agent of Saint Vincent and the Grenadines and the Agent of Spain agreed that, should the Tribunal authorize the presentation of reply and rejoinder, the time-limits for these pleadings would be as follows:

11 December 2011 time-limit for the filing of the Reply by Saint Vincent and the Grenadines,

11 February 2012 time-limit for the filing of the Rejoinder by Spain;

THE TRIBUNAL

Taking into account the agreement of the parties,

Authorizes the submission of a Reply by Saint Vincent and the Grenadines and a Rejoinder by Spain;

Fixes the following time-limits for the filing of those pleadings in the case:

11 December 2011 for the Reply of Saint Vincent and the Grenadines;

11 February 2012 for the Rejoinder of Spain; and

Reserves the subsequent procedure for further decision.

Done in English and French, both texts being authoritative, in the Free and Hanseatic City of Hamburg, this thirtieth day of September, two thousand and eleven, in three copies, one of which will be placed in the archives of the Tribunal and the others transmitted to the Government of Saint Vincent and the Grenadines and the Government of Spain, respectively.
