The International Tribunal for the Law of the Sea,

Having regard to article 27 of the Statute of the Tribunal and to articles 59 and 60 of the Rules of the Tribunal,

Having regard to the Order of the Tribunal of 20 February 1998,

*Fixes* the following time-limits for the pleadings in the case:

19 June 1998 for the Memorial of Saint Vincent and the Grenadines;  
18 September 1998 for the Counter-Memorial of Guinea;  
30 October 1998 for the Reply of Saint Vincent and the Grenadines;  
11 December 1998 for the Rejoinder of Guinea; and

*Reserves* the subsequent procedure for further decision.
